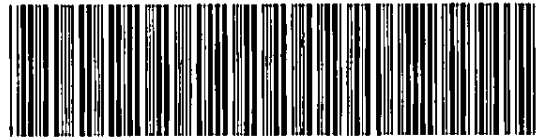

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:




## ARTICLE VIII

### INDEMNIFICATION


