Laws of the State of Florida, it is respectfully requested of the Secretary of State the approval and the following Articles.

The name of this corporation shall be **Honey Drip Collection Inc.** and its principal place of business shall be at 3413 NW 193 Street, Miami Gardens, FL 33056 with the right to change and move said principal place of business and establish such other offices and place of business within or without the State of Florida, as the Board of Directors may from time to time deem proper.

ARTICLE II
