ARTICLES OF INCORPORATION

OF

ICF SOLUTIONS, INC.

Pursuant to Section 607 Florida Statutes, the Articles of Incorporation of ICF SOLUTIONS, INC., which was originally incorporated under the laws of the State of California on October 28, 2005, are hereby stated in their entirety. These Articles have been adopted pursuant to Section 607.1002, Florida Statutes. The Articles of Incorporation of ICF SOLUTIONS, INC. shall henceforth be as follows:

ARTICLE I

NAME AND ADDRESS

The name of the corporation is ICF SOLUTIONS, INC., and its principle address and mailing address are 1777 Carillon Park Drive, Oviedo, FL 32765.

ARTICLE II

DEFINITIONS

For convenience, the corporation shall be referred to in these Articles as "The Corporation".

ARTICLE III

PURPOSE AND POWERS

Section 3.1. <u>Purpose</u>. The purpose of the corporation is to engage in any lawful activity for which corporations may be organized under the laws of the State of Florida.

Section 3.2 <u>Powers and Duties</u>. For the accomplishment of its purposes, the Corporation Shall have all the common law and statutory powers and duties of a corporation for profit under the laws of the State of Florida, except as limited or modified by these Articles or the By-Laws.

ARTICLE IV

SHARES OF STOCK

Section 4.1. <u>Classes of Stock.</u> There shall be only one class of common stock for the Corporation.

The Corporation is authorized to issue ten thousand Section 4.2. Issuance of Stock. (10,000) shares of Common Stock. As of the date of execution of these Articles, one thousand (1.000) shares of Common Stock have been issued as follows:

Alexander Industries, LLC	1,000

Each share of Common Stock in this corporation shall entitle the holder thereof to one vote at any meeting of the corporation's shareholders.

Section 4.3 Entitlement to Distributions. Shareholders are entitled to receive distributions, such as dividends or shares of the net assets of the Corporation upon dissolution, in amounts proportionate to their percentage of ownership of the total outstanding shares of The Corporation.

Section 4.4. Restrictions on Sale or Transfer of Common Stock. The Corporation is authorized to issue stock subject to restrictions on transfer as provided in Chapter 607.0627, Florida Statutes, as amended from time to time. Such restrictions shall be created and enforced by a stock purchase agreement between the Corporation and any proposed shareholder.
