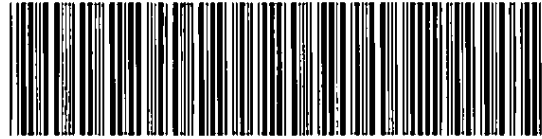

A. The name of the Corporation is: ZIMMERMAN BIOPHARMA HOLDING, INC.


