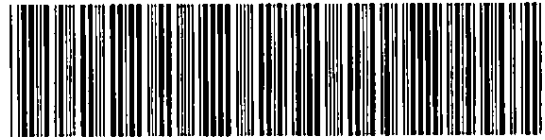



ARTICLES OF INCORPORATION
OF
JABR INVESTMENTS, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME & PRINCIPAL OFFICE

The name of the corporation shall be: **JABR INVESTMENTS, INC.**

The address of the principal office of this corporation shall be 1936-1938 Palm Avenue, Fort Myers, FL 33916.

ARTICLE II. NATURE OF BUSINESS

ARTICLE VIII. DIRECTORS




