THE UNDERSIGNED, for the purpose of incorporating a corporation pursuant to the provisions of Florida Business Corporation Act (the "FBCA"), does hereby certify pursuant to Section 607 and 321 of the Statutes as follows:

Article I: The name of the corporation shall be Certus Florida. Inc. (the "Corporation").
