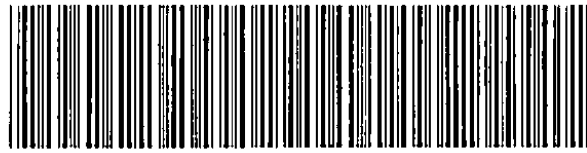




ARTICLE X. BYLAWS
