Dear Sir/Madam

I am the President of the referenced Florida Corporations for which I am enclosing annual UBRs and filing fees. There is an issue of late submissions of these documents and payments, for which I invite your consideration, and a favorable decision.

At the end of last year, I moved my personal address from Seattle, and there were associated changes in the Florida business addresses. Shortly before the normal UBR filing deadline of May 1, I had not received the 2001 forms, no doubt due to the moves - I had experienced other mail delays - and called your office requesting that these be forwarded to the above address. When these had not been received by 25 April, I mailed my check for \$300 to your office with a covering letter explaining the circumstances, and asking that the address changes be noted. They had also been advised to your office earlier.

As you know, no acknowledgement of fee receipts is provided. Due to bank changes for my businesses associated with the above move, I did not have the prompt visibility of check payments normally expected, and so was unaware that receipt of my check had not been confirmed by a bank statement listing. By now, it is assumed to have been lost.

A few weeks ago, I did receive the UBRs at my new address, with annotations that they should be completed and returned to your office by 12 September, but with \$400 late payment fees. This was the first written indication that my earlier filing was incomplete, and could have been interpreted as responding to my earlier request.

You will note that these businesses have been operating for a number of years, and that there has never been a delayed annual filing before. May I ask that you consider accepting the enclosed filings and payments in the normal way, with no late fees, due to the extenuating circumstances which I have outlined?
