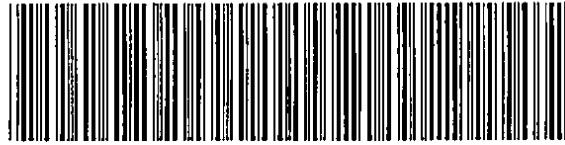

**ARTICLES OF INCORPORATION
OF
SINGH TECHNOLOGIES INC.**

**ARTICLE I
NAME**

The name of this corporation is Singh Technologies Inc.

**ARTICLE II
DURATION**

This corporation shall have perpetual existence, commencing on the date of filing of these Articles with the Secretary of State of the State of Florida.

**ARTICLE III
PURPOSE**

This corporation is organized for the following purposes:

A. To transact any and all lawful business.

B. To do all and everything necessary and proper for the accomplishment of any of the purposes of the corporation or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the corporation, and, in general, either alone or in association with other corporations, individuals or entities, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes of objectives of this corporation.

C. The foregoing paragraphs shall be construed as enumerating both objectives and purposes of this corporation and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

**ARTICLE IV
POWERS**

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

ARTICLE V CAPITAL STOCK

A. The corporation is authorized to issue one hundred (100) shares of \$0.01 par value common stock, ten (10) shares of which shall be designated as "Voting Common Stock" and ninety (90) shares of which shall be designated as "Non-Voting Common Stock."

B. Except as otherwise provided by law or in the bylaws of the corporation, the entire voting power for the election of Directors and for all other purposes shall be vested exclusively in the holders of the outstanding Voting Common Stock.

ARTICLE VI ADDRESS

The initial street address of the principal office of the corporation is: 1912 NW 67th Place, Gainesville, Florida, 32653, and the registered office of this corporation is: 1912 NW 67th Place, Gainesville, Florida, 32653, and the name of the initial registered agent of this corporation is Deepika B. Singh. The Board of Directors may from time to time move the principal or registered office to any other address in Florida or change the corporation's registered agent.

ARTICLE VII DIRECTORS

The business and affairs of the corporation shall be managed by a Board of Directors consisting of not less than one person. The number of directors may be increased or diminished from time to time by the bylaws.

The shareholders reserve the power to adopt bylaws and to prescribe in any bylaws that such bylaws shall not be altered, amended, or repealed by the Board of Directors.


ARTICLE XII MEETINGS
