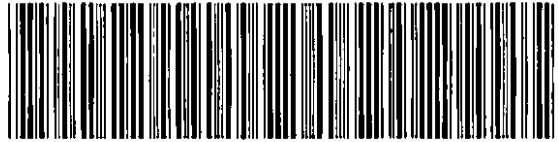

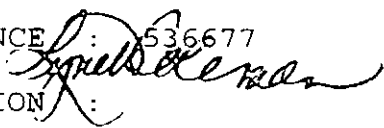

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Santa Ines Holdings Inc., a Florida benefit corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

SECOND: The Articles of Incorporation of the Corporation are hereby amended by deleting the entire Article I as it now exists and inserting in lieu thereof a new Article I, reading as follows:
