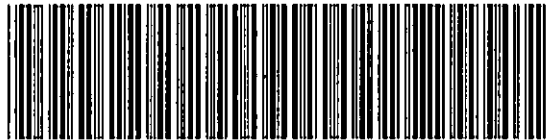



The name of the corporation is **FrontLine Generation Group, Inc.**
