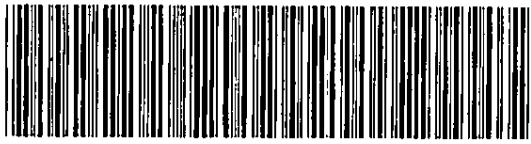

Thanks for your assistance in this matter, I appreciate it. I am trying to relocate my Pennsylvania S-Corp to the State of Florida. I already have a Federal EIN number & entity. I was told that the first step was to fill out the LNHS53 form for Domestication to the State of Florida. One that process is complete. I will receive a number that can be used on the Florida DR-1 form (Florida Business Tax Application)

After speaking with you previously I was told to remove the "LLC" from the entity name and all locations on the Domestication form. Replace "LLC" with "Corporation" and write my Federal EIN number on the last page of the form. I did that and resubmitted on 1/20/20 but have heard no response.
