

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION ECRETATE OF STATE OF TYLLABA ISEE, FL

SAILFISH BREWING COMPANY, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE 1 - NAME

The name of the corporation is SAILFISH BREWING COMPANY, INC. (hereinafter referred to as the "Corporation"), Florida Document Number P20000009634.

ARTICLE II - TEXT OF AMENDMENT

Article III of the Articles of Incorporation is amended in its entirety by replacing it with the following:

"ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is two hundred million (200,000,000), shares of common stock having a par value of Five Cents (\$0.05) per share."

ARTICLE III - EFFECTIVE DATE OF AMENDMENT

The effective date of the amendment to the Articles of Incorporation of the Corporation set forth herein will be as of the date of filing with the Florida Department of State.
