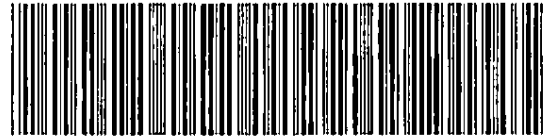

ARTICLE I

Name

The name of the corporation is Greenhouse Hardware Company (the "Corporation").

ARTICLE II

Principal Office

ARTICLE III

Incorporator

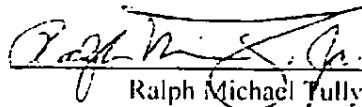

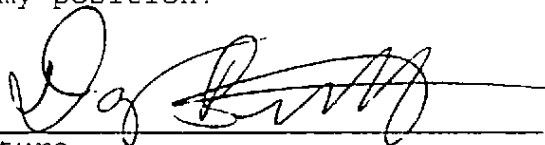
