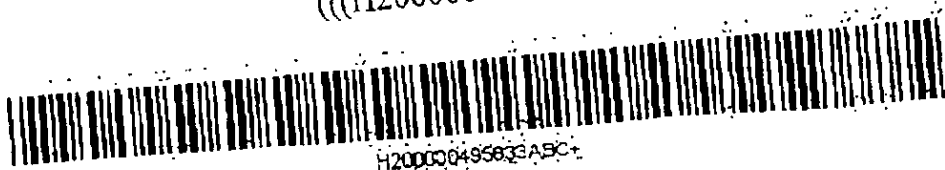

I the undersigned incorporator of a Corporation under the Professional Service Corporation Act adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the Corporation is All Clear Customs, Inc.
