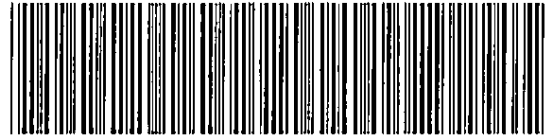

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is: **DAL PLIN BRICKELL, INC.**

ARTICLE II

The street address of the initial principal office and mailing address of the Corporation is 200 S. Andrews Avenue, Suite 900, Fort Lauderdale, Florida 33301.

ARTICLE III

The maximum number of shares of stock which this Corporation is authorized to issue or to have outstanding at any time shall be 10,000 shares, \$0.01 par value per share, of common stock.
