

ARTICLES OF INCORPORATION

FOR

PUMP N DUMP USA, INC., A FLORIDA CORPORATION

The undersigned, acting as incorporator for this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby form a Business Corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I NAME OF CORPORATION

The name of the corporation shall be PUMP N DUMP USA, INC., A FLORIDA CORPORATION

ARTICLE II TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 24 day of January, 2020, and shall exist perpetually.

ARTICLE III GENERAL PURPOSE

The general purpose for which this corporation is organized shall be the conduct of general business and related services and sales, and all things in connection therewith that are related under the laws of the State of Florida.
