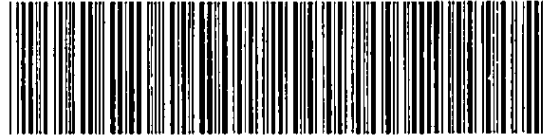

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is TRINITY CONTRACTOR MEDIA, INC., and the principal address and principal place of business is 11327 43rd Street North, Clearwater, Florida 33762.

ARTICLE II - REGISTERED OFFICE AND AGENT
