**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of Blue Gold Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Blue Gold Inc. (the "Corporation").

ARTICLE II. ADDRESS

The name and street address of the incorporator is Norberto E. Quintana, 701 Brickell Avenue, Suite 3300, Miami, FL 33131.


ARTICLE IX. BYLAWS


