This corporation is authorized to issue one hundred (100) shares of \$5.00 par value common stock.

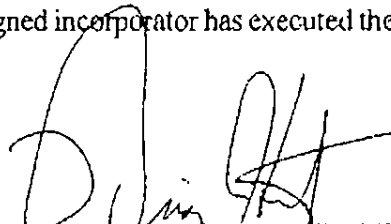
