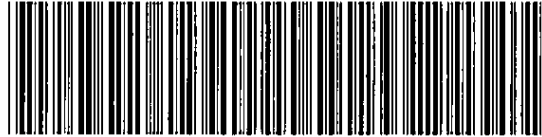

**ARTICLES OF INCORPORATION
OF
SHELTER BAY YACHT CLUB, INC.**

This is to certify that the undersigned does hereby establish a corporation under and by virtue of the provisions of Chapter 607, Title XXXVI, Florida Statutes and acts amendatory thereof, for the purposes and under the corporation hereinafter mentioned, and to that end, does, by these Articles of Incorporation, set forth the following:

ARTICLE I – NAME

The name of the corporation is SHELTER BAY YACHT CLUB, INC.

ARTICLE II – PRINCIPAL OFFICE AND MAILING ADDRESS

The mailing address of the corporation is 214 Arnold Avenue, Morristown, TN 37813, and the principal office address of the corporation is 77 Coco Plum Drive, Marathon, FL 33050.

ARTICLE III – REGISTERED AGENT AND ADDRESS

The address of the initial registered offices of the corporation shall be 489 Madison Court, Fort Myers, FL 33931 and the name of the initial registered agent for the corporation shall be James Figuerado, Jr., a resident of the State of Florida.

ARTICLE IV - PURPOSE

The nature of the business and the objects and purpose or purposes to be transacted, promoted, or carried on by the corporation are to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida. In addition, the corporation

shall have the power to carry on business of any character that is not prohibited by law or required to be stated in the articles.

ARTICLE V – AUTHORIZED SHARES

The total number of shares which this corporation is authorized to issue is 100 shares of common stock with One and 00/100 (\$1.00) Dollar par value for each share. Shareholders of the corporation shall have a preemptive right to purchase treasury or non-issued capital stock of the corporation and to vote their shares on a cumulative basis for the election of the Board of Directors.

ARTICLE VI – INITIAL OFFICERS AND/OR DIRECTORS

The manner in which the officers and directors are elected is stated in the Bylaws of the corporation. The initial Board of Directors of the corporation shall consist of one (1) person, and the name and address of the individual who is to serve as the President/Secretary/Treasurer and as the initial director of the corporation is as follows:
