ARTICLES OF INCORPORATION OF NRRG INVESTMENTS I, INC.

ARTICLE I NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is NRRG Investments I, Inc.

Section 1.2 <u>Address of Principal Office</u>. The principal address and mailing address of the corporation is One Independent Drive, Suite 114, Jacksonville, Florida 32202.

Section 2.1 Duration. This corporation shall exist perpetually.
