Pursuant to Section 607.1007 of the Business Corporation Act of the State of Florida, the undersigned, being the President of Nsure Insurance Services Inc. (hereinafter the "Corporation"), a Florida corporation, and desiring to amend and restate its Articles of Incorporation, does hereby certify:

FIRST: Articles of Incorporation of the Corporation were filed with the Secretary of State of Florida on March 5, 2020, Document No. P20000021759.

SECOND: Amended and restated articles of incorporation were unanimously adopted by all of the directors and a all of the holders of the voting stock of the Corporation pursuant to sections 607.0821 and 607.0704 of the Florida Business Corporation Act on March 4, 2021.
