ARTICLES OF INCORPORATION
OF
CITRUS SERVICE ORGANIZATION, INC.

The undersigned, acting as incorporator of a corporation being formed under the Florida Business Corporation Act, Chapter 607, Florida Statutes, adopts the following articles of incorporation:

ARTICLE I
Name

The name of the corporation is Citrus Service Organization, Inc. (the "Corporation").

ARTICLE II
Initial Principal Office and Mailing Address

The address of this corporation shall be 600 N. Broadway Avenue, Suite 101, Bartow, Florida 33830, or such other address within the State of Florida as the Board of Directors may from time to time designate. The mailing address of this corporation shall be Post Office Box 1576, Bartow, Florida 33831-1576.

ARTICLE III
Nature of Business

The Corporation may engage in any activity or business permitted under the laws of the United States and State of Florida. The purpose of the corporation shall be to actively engage in the American political process at the local, state and national level; and do any and all things permitted to be done by a political party by the laws of the United States and to do any and all things permitted to be done by a political party under the laws of the State of Florida.

ARTICLE IV
Capital Stock

The Corporation shall have authority to issue one hundred (100) common shares with a par value of \$1.00 per share.

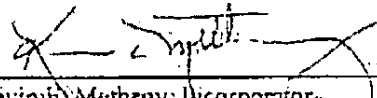

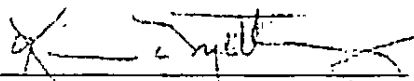
