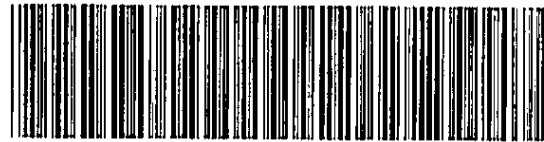

ARTICLE I - NAME

The name of this Corporation is COOK & VORNDRAN-BROWN, INC. and the principal business address of the Corporation is COOK & VORNDRAN-BROWN, INC., 1884 McGirts Point Blvd., Jacksonville, FL 32221.

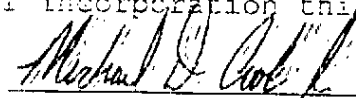
