

ARTICLES OF INCORPORATION OF FUSE THE ARTZ ENTERPRISES, INC

If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions remaining shall not be otherwise affected. All references in these Articles of Incorporation to "member," "officer," "employee" and "agent" shall include the heirs, estates, administrators, executors, and personal representatives of such persons.
