
Mr. O'Keefe,

I received the note below. The Kloset Kouture Inc was our corp entity. We had a financial officer of our company, David Byck, who was supposed to file an annual report and did not. The corporation, without notice, was dissolved in September even though we were still in operation and remain operating.

We have no intention of paying reinstatement fees to reinstate and would like to use the new incorporated name. Please advise what you might need from us other than this note.

Our preference would have been to retain The Kloset Kouture. Unfortunately there was no flexibility on the fee to reinstate which seems to be quite punitive considering an annual reporting (we missed one) is \$150 which we are willing to pay and a new corporation is only \$70!

The \$900 fee appears to be non-negotiable forcing us to go in this direction. Please confirm there is absolutely nothing else that can be done to retain our original name and EIN without paying \$900. If there remains nothing we can do please advise what else is needed from us to move to Kloset Kouture Inc. as we applied for. Thank you.
