

CERTIFICATE OF INCORPORATION OF C.E.W. FOTOGRAFEE INC.

For the purpose of forming a corporation for profit under the general incorporation

Laws of the State of Florida, it is respectfully requested of the Secretary of State the approval of such incorporation under the following Articles.

ARTICLE I

The name of this corporation shall be **C.E.W. Fotografee Inc.** and its principal place of business shall be at 8740 NW 15 Ave. Miami, FL 33147 with the right to change and move said principal place of business and establish such other offices and place of business within or without the State of Florida, as the Board of Directors may from time to time deem proper.

ARTICLE II
