**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
DOW EQUITY HOLDINGS, INC**

SMART Equity Holdings, Inc, a Florida corporation (the "**Corporation**"), in order to amend its Articles of Incorporation in accordance with Section 607.1003 of the Florida Business Corporation Act (the "**Act**"), does hereby deliver the following Articles of Amendment in accordance with Section 607.1006 of the Act:

FIRST: The name of the Corporation is DOW Equity Holdings, Inc.

SECOND: These Articles of Amendment contain an amendment to the Corporation's Articles of Incorporation, as originally filed on March 31, 2020 (the "**Articles of Incorporation**"), requiring shareholder approval.

THIRD: The Articles of Incorporation are hereby amended to add Article VI as follows:

"Article VI. OFFICERS OF COMPANY"

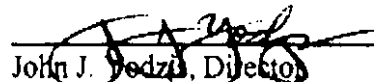
