ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SMART EQUITY HOLDINGS, INC

SECOND: These Articles of Amendment contain an amendment to the Corporation's Articles of Incorporation, as originally filed on March 31, 2020 (the "Articles of Incorporation"), requiring shareholder approval.
