ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, being duly licensed to practice public accounting under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, Florida Statute Chapter 621, and other laws of the State of Florida.

ARTICLE I. NAME

The name of the professional service corporation is LESLIE A. TUCKER, CPA, P.A.

ARTICLE II. PRINCIPAL OFFICE
