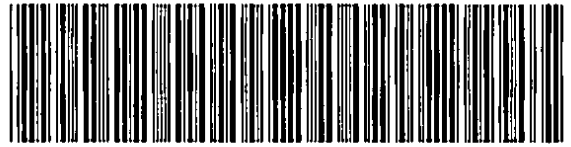



THE UNDERSIGNED, for the purposes of forming a corporation, pursuant to Florida Statutes 607 and/or Chapter 621 F.S., do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the Corporation is:

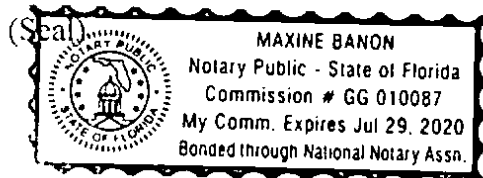




