

# Article IX Share Powers

The classes and maximum number of shares that the corporation is authorized to issue is 5.000.000 Class A Common Shares. The rights, privileges, restrictions and conditions attaching to the Class A Common Shares of the corporation are as follows:

## **Class A Common Shares**

Dividends. The holders of the Class A Common Shares shall be entitled to receive such non-cumulative dividends if, as and when declared by the board of directors of the Corporation out of the assets of the Corporation properly applicable to the payment of dividends in such amounts and payable in such manner as the board of directors may from time to time determine, provided that, in the case of distributions received by the Corporation from DMCC Performance 2, LP (the "Partnership") as a result of distributions paid on Class A limited partnership units of the Partnership (a "Class A Distribution"), the Corporation shall cause the amount of such Class A Distribution to, in turn, be distributed to each holder of Class A Shares based on each such holder's pro rata portion of the total number of Class A Shares outstanding.

Liquidation. Dissolution or Winding Up. In the event of the liquidation, dissolution or winding up of the Corporation, or any other distribution of assets of the Corporation among its shareholders for the purpose of winding up its affairs, the holders of the Class A Common Shares shall be entitled to receive the assets of the Corporation upon such a distribution and be entitled to participate ratably in any distribution of the assets of the Corporation.

## **Voting**

The holders of the Class A Common Shares are entitled to receive notice of, attend and vote (in person or by proxy) at all meetings of shareholders of the Corporation, except where holders of another class are entitled to vote separately as a class as provided in the Florida Business Corporation Act.

Each Class A Common Share entitles the holder to one vote at any meeting at which the holders of the Class A Common Shares are entitled to vote.
