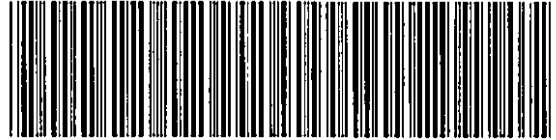

ARTICLE I – NAME

THE NAME OF THIS CORPORATION IS:

COAST 2 COAST MOTOR LINES INC

ARTICLE II – DURATION

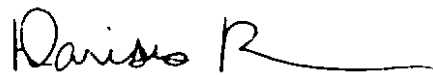
ARTICLES XI – PRE- EMPTIVE RIGHTS

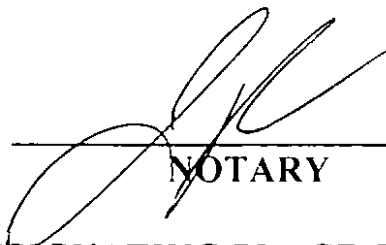

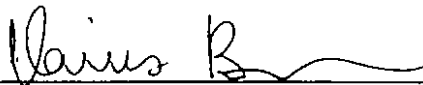

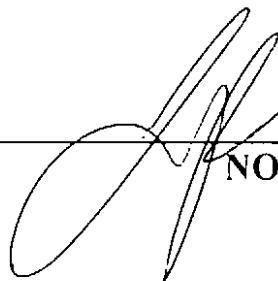
