**ARTICLES OF INCORPORATION
OF
*Kelly's Caring Angels, Inc.***

The undersigned Incorporator, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of this corporation shall be **Kelly's Caring Angels, Inc.**

**ARTICLE II
EFFECTIVE DATE OF INCORPORATION AND TERM OF EXISTENCE**

The effective date of this incorporation shall be May 12, 2020. This Corporation shall have perpetual existence unless sooner dissolved according to law, and its existence shall commence on May 12, 2020 as reflected in the Certificate of Incorporation issued by the Secretary of State of Florida.

**ARTICLE III
NATURE OF BUSINESS**

The general purposes for which this Corporation is organized are the following:

- A. To engage in and transact any lawful business for which a corporation may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of this Corporation or necessary or desirable in order to accomplish them.

AMENDMENT




