

ARTICLES OF INCORPORATION OF Kelly's Caring Angels, Inc.

FILED SECRETARIASSES FLORID

The undersigned Incorporator, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be Kelly's Caring Angels, Inc.

EFFECTIVE DATE OF INCORPORATION AND TERM OF EXISTENCE

The effective date of this incorporation shall be May 12, 2020. This Corporation shall have perpetual existence unless sooner dissolved according to law, and its existence shall commence on May 12, 2020 as reflected in the Certificate of Incorporation issued by the Secretary of State of Florida.

ARTICLE III NATURE OF BUSINESS

The general purposes for which this Corporation is organized are the following:

- A. To engage in and transact any lawful business for which a corporation may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of this Corporation or necessary or desirable in order to accomplish them.

ARTICLE IV INITIAL CAPITAL

The amount of capital with which this Corporation shall begin business shall be determined in the sole discretion of the Incorporator and/or the Board of Directors.

ARTICLE V CAPITAL STOCK

The aggregate number of shares which this Corporation is authorized to issue is ONE THOUSAND (1000) shares of common stock. Such shares shall be of a single class and shall have a par value of Fifty Cents (\$.50) per share.

ARTICLE VI SPECIAL PROVISION - Indemnification

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

ARTICLE VII PRINCIPAL ADDRESS OF BUSINESS
