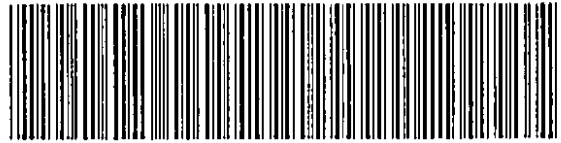

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, Section 607.0202, Florida Statutes, does hereby adopt the following Articles of Incorporation.

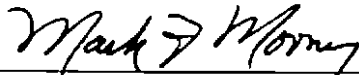

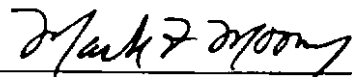
