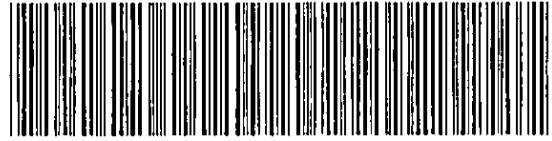

Persuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is BLUESKY INDUSTRIAL, INC. (the "Corporation").
2. The following amendment to the Articles of Incorporation of the Corporation was adopted by the Shareholders of the Corporation (the number of votes cast being sufficient for approval) and the Board of Directors of the Corporation by the Joint Written Consent of the Shareholders and Board of Directors in Lieu of a Special Meeting dated May 13, 2020, in the manner prescribed by Sections 607.1003 and 607.1006 of the Florida Business Corporation Act:

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
