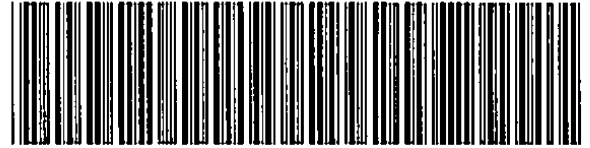



Pursuant to the provisions of Florida Statutes §607.1006, Title, Inc., a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation, as follows:

FIRST: Article III is hereby deleted and is further amended to read as follows:

"ARTICLE III. CAPITAL STOCK.

The maximum number of share of stock that this corporation is authorized to have outstanding at any one time is One Thousand Five Hundred (1,500) shares of common stock having a par value of \$10.00 per share: This corporation will begin business with Fifteen Thousand dollars (\$15,000.00)."

SECOND: The remainder of this Corporation's Articles of Incorporation shall remain in full force and effect.

THIRD: The date of adoption of this amendment is May 12, 2020 and will be effective as of May 12, 2020.

FOURTH: The amendment was adopted by the Board of Directors without shareholder action and shareholder action was not required.

FIFTH: The manner of the adoption of these Articles of Amendment and the vote by which they were adopted constitute full legal compliance with the provisions of applicable law, the Corporation's articles of incorporation, and the Corporation's bylaws.
