**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **M&E BONDING AGENCY, INC.**, and its principal place of business shall be located at 1418 Rose Street, Key West, FL 33040, and the mailing address shall be 1418 Rose Street, Key West, FL 33040.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of any and all lawful business.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares this corporation is authorized to issue is one thousand (1,000) shares of common stock at One Dollar (\$1.00) par value, which shall be designated as "Common Shares." The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than thirty-five (35) natural persons, or the estate of such natural persons. Additionally, no stock shall be issued or transferred to a nonresident alien. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1418 Rose Street, Key West, FL 33040, and the name of the initial registered agent of this corporation at that address is Manuel Patrick Ortega.

ARTICLE VI - DIRECTORS

Initially, this corporation shall have one (1) Director who shall serve until his successors shall be elected/appointed at the first meeting of the stockholders. ARTICLE IX - INDEMNIFICATION






