

## Certificate of Incorporation of

### Yasso Business Consultants Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 1000 of which 500 shares of par value \$0.01 per share shall be designated as Common Stock and 500 shares of par value \$0.01 shall be designated as Preferred Stock.
