The undersigned Incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

**ARTICLE I  
NAME AND PRINCIPAL OFFICE**

The name of this Corporation shall be **MEDLEY MARINE, INC.** The principal place of business and mailing address of this Corporation shall be 3216 Bayou Lane, Pensacola, FL 32503.

**ARTICLE II  
NATURE OF BUSINESS**

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.


