#### ARTICLES OF INCORPORATION OF MEDLEY MARINE, INC.

The undersigned Incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

#### ARTICLE I NAME AND PRINCIPAL OFFICE

The name of this Corporation shall be MEDLEY MARINE, INC. The principal place of business and mailing address of this Corporation shall be 3216 Bayou Lane, Pensacola, FL 32503.

#### ARTICLE II NATURE OF BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
