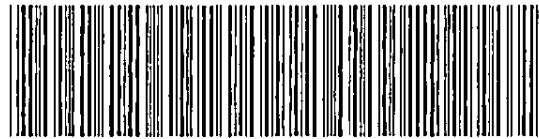

PROPERTY OR LABOR MAY ALSO BE PURCHASED WITH THE CORPORATE ASSETS SUCH VALUATION AS MAY BE FIXED BY THE DIRECTORS.
- B. THE SAID STOCK SHALL BE ISSUED PURSUANT TO A PLAN UNDER SECTION 1244 OF THE INTERNAL REVENUE SERVICE CODE.
- C.
