**ARTICLES OF INCORPORATION  
OF  
MARION SIGN COMPANY, INC.**

The undersigned, Donald F. Toler, hereby presents these Articles of Incorporation as the Articles of Incorporation for MARION SIGN COMPANY, INC. pursuant to Chapter 607, Florida Statutes.

**ARTICLE I - NAME**

The name of the corporation is Marion Sign Company, Inc. This corporation is referred to in these Articles of Incorporation as the "Corporation."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The mailing and street address of the principal office of the Corporation is 186 Hollow Log Lane, Freeport, FL 32439.

**ARTICLE III - PURPOSE AND POWERS**

**ARTICLE VII - OFFICERS**

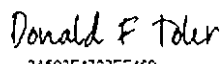

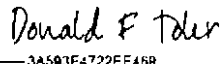
