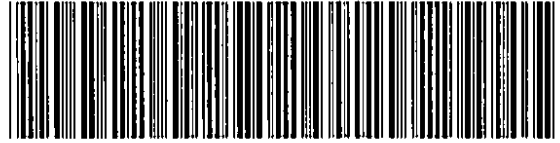

ARTICLES OF INCORPORATION

OF

Name of Corporation
