

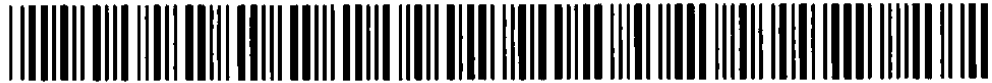

**ARTICLES OF INCORPORATION  
OF

**ARTICLE ONE:**
