PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 2565 NE 182 STREET, NORTH MIAMI BEACH, FL. 33160.

ARTICLE III.

PURPOSES

The purpose for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:
