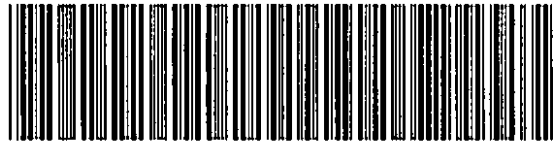

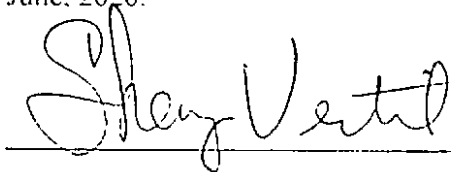
ARTICLE IX – AMENDMENT OF ARTICLES
