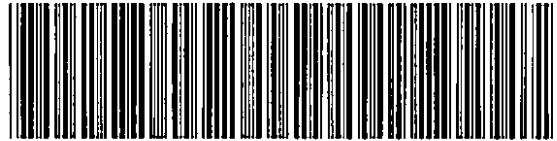

**ARTICLES OF INCORPORATION
OF
RISING TIDE SOLUTIONS, INC.**

The undersigned, desiring to form a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for formation, liability, rights, privileges and immunities of a corporation for profit, does hereby certify as follows:

**ARTICLE I
NAME**

The name of this corporation shall be RISING TIDE SOLUTIONS, INC. The mailing address of the corporation shall be Post Office Box 438, Terra Ceia, Florida, 34250, and its initial physical office address shall be 1655 Center Road, Terra Ceia, Florida, 34250.

**ARTICLE II
TERM OF EXISTENCE**

This corporation shall have perpetual existence.

**ARTICLE III
PURPOSE OF CORPORATION**

The general purpose of the business to be transacted by the corporation shall be to own and operate a Kumon Math and Reading Center franchise and for all other uses incidental thereto.
